Health /Genetic Guarantee

The breeder guarantees that the puppy is in the best health, as far as appears to the eye, has
been assessed by a veterinarian, and has received appropriate medical vaccinations, worming
and care. The breeder will supply a list detailing medical treatment your puppy received under the
breeder's care, and any future care essential to puppy's wellbeing is to be discussed by you with
a veterinarian of your choice.

The breeder does not accept liability for any injury or illness, once the puppy is in your care.

The breeder does not accept any liability for dental care, you and your veterinarian may decide to
undertake for your puppy.

Should your puppy develop a genetically derived medical disorder before the age of Two (2)
years and the diagnosis is confirmed by two un-associated veterinarians, one (1) to be chosen by
the buyer and one (1) chosen by the breeder, thereby causing the buyer and the breeder to
agree that the puppy is unsuitable as a pet, the breeder will upon receiving medical reports,
provide the buyer with the following options.

(NOTE all veterinary cost and testing expenses are the buyer's responsibility.)

- a) The buyer may elect to relinquish the puppy to the breeder and in agreement with the breeder
the buyer can choose to select another similar puppy from a future litter.
The current puppy must be returned to the breeder prior to receiving the new puppy.

or

- b) The buyer may elect to retain the puppy therefore the breeder will provide a refund up to the purchase price of the puppy within 30days upon receiving supporting documentation from the two nominated veterinarians stating that in their opinion the condition is primarily genetic in nature and not due to environmental causes such as obesity, accident or injury.

The breeder shall not be held responsible for the development of disqualifying faults, diseases or disorders, which are due to the buyer's negligence and/or environmental factors.

Therefore, the buyer agrees that they will make no further claim of any nature against the breeder and hereby release the breeder from any liability and responsibility for any illness, disease, accident, injury or death of the puppy.

General

The buyer understands that the Australian Labradoodle is an intelligent dog and will require early socialization and training. The breeder strongly recommends that the buyer attends obedience classes with the puppy and provide proper socialization opportunities.

The buyer agrees to never relinquish puppy to an animal shelter or rescue organization. The breeder will assist the buyer (if required) in finding a suitable new home for the puppy if the need arises during its lifetime.

The buyer agrees to allow the breeder to use photographs of the puppy for advertising purposes.

The buyer agrees to consider appropriate pet insurance before the current Petplan cover expires 6 weeks from date of collection.

The buyer assumes the responsibility to continue appropriate vaccinations, worming, and health care as recommended by your chosen veterinarian.

The buyer agrees to feed the puppy a high-quality diet and maintain the puppy in a healthy weight throughout its growth period.

The buyer agrees to prevent excessive exercise or activities that will put strain on growth plates or cause soft tissue injuries.

There are many factors that can influence the growth, development and health of a puppy, such as diet, exercise, weight, and environmental conditions.

Should the buyer choose to break any of the above portions of the agreement, the remaining duration of the agreement will be considered null and void.
